1. The Bali Guidelines

Adopted by UNEP's Governing Council in

2010

A tool to assist countries in filling gaps in national and sub-national legislation in order to facilitate broad access to information public participation and acce environmental matters

NATIONAL LEGISLATION ON ACCESS TO INFORMATION, FUELIC PARTICIPATION AND ACCESS TO JUSTICE IN ENVIRONMENTAL MATTERS

Rio+20: "The Future We Want":

The upgraded UNEP to "ensure the active participation of all relevant stakeholders drawing on best practices and models from relevant multilateral institutions and exploring new mechanisms to promote transparency and the effective engagement of civil

society."



3. Applying Principle 10 at UNEP

UNEP GC Decision 27/2, February 2013:

- Paragraph 5 (e): multi-stakeholder dialogue during UNEA
- Paragraph 7: Active participation of stakeholders, drawing in best practices and models from relevant multilateral organizations, in UNEA and subsidiary bodies:



- » Paragraph 7 (a): Developing by 2014 a process for stakeholder accreditation and participation that builds on the existing rules of procedures and takes into account inclusive modalities of the Commission of Sustainable Development and other relevant United Nations bodies;
- » Paragraph 7(b): Establishing by 2014 mechanisms and rules for stakeholder expert input and advice;
- » Paragraph 7(c): Enhancing by 2014 working methods and processes for
 informed discussions and contributions by all relevant stakeholders towards
 the intergovernmental decision-making process

Paragraph 10: Open ended CPR with stakeholder participation

Paragraph 17: Access to Information Policy

4. UNEP and Principle 10 in Latin America

- Declaration on the application of P 10 in Latin America and the Caribbean was signed in June 2012 in Rio de Janeiro
- Development of Regional Legal Instrument with the assistance of UN ECLAC
 - ✤ Negotiations are on the way, most likely to be finish in 2017
 - 22 Signatory Countries Latin American and the Caribbean
- ✤ UNEP Support:

- Bali Guideline Implementation Guide

- Outreach, e.g. through the United Nations Environment Assembly

5. UNEP and Principle 10 in Africa

- Interest to further Principle 10 but not formal process as in LAC
- Recognition of the importance of Principle 10, e.g. AMCEN
- Principle 10 legislation existing at national level but often implementation deficit
- Lack of application of democratic principles prevents P 10 application
- Weak institutions, lack of resources
- UNEP Support:
- Bali Guideline Implementation Guide, Spanish and Arabic version underway

- Call upon UNEP to develop a roadmap for the development of a regional or sub-regional Principle 10 instrument for Africa

6. UNEP and Principle 10 in Asia Pacific ?

- UNEP's actual engagement in further developing Principle 10 is limited to:
 - Engaging Civil Society from the region in UNEP's work at regional and global level, e.g. in UNEA
 - Partnership with the Asia Pacific Regional CSO Engagement Mechanisms
